Minutes of the Meeting:

Chairperson Dr G.P. Dutta welcomes all the members of the Institutional Animal Ethical Committee (IAEC) of Rammohan College, Kolkata. The main nominee Dr Sarbani Hazra was absent as she is currently on sabbatical at the University of Colorado, USA. Therefore, with a kind consent of the main nominee, the meeting was conducted by Dr Pratip Chakraborty, Link nominee, as per the CPCSEA / CCSEA rules and regulations. Dr M. Imran Khan, Scientist from outside the Institute (CPCSEA / CCSEA nominated), attended the meeting online as he was in Mumbai. Other members attended the meeting in the offline mode.

Item No. 1: Confirmation of the Proceedings of the last meeting dated 27th September 2022

Chairperson requested Dr S. N. Banerjee to read the Minutes of the last IAEC meeting. The proceedings of the last meeting dated 27th September 2022 were read and confirmed.

Item No. 2: Renewal of Animal House Registration

Member Secretary Dr Samarendra Nath Banerjee mentioned that validity of this IAEC, Rammohan College, is going to terminate on 27th February 2023. Therefore, reconstitution is mandatory, and the portal for renewal appeal will open 40 days before the date of validity termination. In continuation of the discussion, members suggested that for the new committee, at least 50% of the existing internal members should be changed, selected members should be below 65 years of age and have a permanent veterinarian to ensure proper care and well-being of laboratory animals. Member secretary further mentioned that he and Chairperson Dr Gouriprasad Datta would retire on 31st December 2023. Thus, they will be exempted automatically from the new committee. Dr Avijit Rakshit, the Veterinarian, mentioned that although a full-time veterinarian is mandatory in an animal house facility, exemption for part-time veterinarians will be at the discretion of the CPCSEA/CCSEA based on the duration and number of animals being kept. Dr. Pratip Chakraborty, Link nominee mentioned since only four Form B has been approved by the IAEC, Rammohan College; a contractual/part time veterinarians may be incorporated as veterinarian member (G.O. no: 25/28/2017-CPCSEA dated 26.09.2019). Dr M. Imran Khan added that it would always be difficult to appoint a full-time veterinarian for an institute with the main target of teaching. Dr Pratip Chakraborty, Link nominee, mentioned that the selection of internal members for new IAEC is under the institute's discretion, but it should be made following CPCSEA/CCSEA guidelines.

Item No. 3: Animal House visit

Chairperson and Member Secretary requested Link nominee for animal house inspection. After the visit, he made queries about the CCTV installation, although overall satisfied with the condition of the animal house. In this context, the Member secretary mentioned that the purchase process of CCTV is ongoing for installation at animal house.

Item No. 4: Decision/ Recommendation of IAEC on New Research Protocols:

There was no proposal for discussion in this meeting.


